INFORMATION FOR OUR CUSTOMERS – concerning the restriction of certain substances in products

Corning considers the protection of the environment and natural resources as one of its most important business tasks and devotes significant efforts and resources to the development of clean products and processes.

The Restriction of Hazardous Substances (RoHS) Directive (Directive 2002/95/EC, recast as Directive 2011/65/EU with amendment by Directive 2015/863) applies in the European Union (EU) to electronic and electrical equipment.

A good portion of our products is not impacted directly by the RoHS rules. Nevertheless, we are continuously striving to avoid or replace the substances in our products which are restricted by the RoHS Directive and other pieces of product legislation.

According to the RoHS Directive, the use of the following ten substances: Cadmium (Cd), hexavalent Chromium (CrVI), Mercury (Hg), Lead (Pb), Polybrominated Biphenyls (PBD), Polybrominated Biphenyl Ethers (PBDE), Bis(2-ethylhexyl) phthalate (DEHP), Butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP) and Diisobutyl phthalate (DIBP) in electrical and electronic equipment put onto the European market is subject to the following maximum concentration values: 0.01% by weight for Cd and 0.1% by weight for the remaining substances.
